You are receiving this letter because you either hold a current private pesticide applicator's license, or your license recently expired. There is an upcoming opportunity to either renew your private applicator's license, or earn pesticide education credits.

Fergus/Petroleum County Extension will be hosting an **Initial Training** program on **May 15**th in **Lewistown.** The event will be held in the upstairs room of **Central Feed Grilling Co. from 8:15am to 5:15pm.** See the included agenda for more details.

This program provides a no-test option for private applicators to renew or obtain their license, and will also provide 6 pesticide education credits for individuals who have a current license. You must attend the entire course to receive a license/credits.

The fee for this class is \$20, which includes catered lunch and materials. Individuals from Fergus and Petroleum Counties who are using the class to obtain/renew their private applicator's license will also need to pay \$48 to the Montana Department of Agriculture, which will cover the cost of their license through 2022. Individuals from other counties are welcome to attend, but the licensing fee will vary depending on location.
